### **VENUE RULES**

- A gelling station will be set up on the pool deck. Gelling must be in designated areas; not in the locker room
- No de-gelling in the showers, in the pool or on the pool deck. For anyone leaving directly from the pool to the airport, buckets with hot water will be provided for degelling, and teams may also request late hotel checkouts.
- No glass and no cooking is allowed on the pool deck; coolers may be brought into the facility.
- Shade structures
  - Limited shade from permanent structure at the top of bleachers
  - Portable, personal shade structures brought in must be anchored (buckets/rope/zipties)

### **SPECIAL EVENT:**

In conjunction with National Breast Cancer Awareness Month and in partnership with Susan G. Komen for the Cure®, a special event is planned during the competition. We will be attempting to set a **Guinness World Record™ for the “World’s Largest Float Pattern”** in the shape of the Komen pink ribbon™. Our goal is to bring national attention to the sport of synchronized swimming and breast cancer awareness in a unique and memorable way. We have all been touched by breast cancer in some way and what better opportunity to support this important cause than with a “*natural*” for synchronized swimmers...a floating pattern with as many as 200+ athletes, officials, friends and survivors. If you can do a tub, we need you! We hope to draw national media coverage for this attempt. All athletes are encouraged to participate; however, this is an optional event. The event is scheduled for 11:00am-12:00 on Saturday, October 15, 2011.

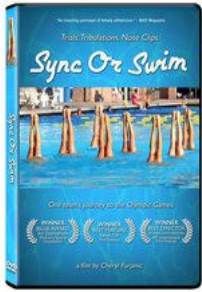
